### FOLIAR APPLICATIONS:

Mix SEA-ZYME Seaweed Extract at the rate of 2-4 quarts per acre per application. Use SEA-ZYME Seaweed Extract as many times as needed throughout the growing season. SEA-ZYME Seaweed Extract can be applied with most crop protection sprays.

### SOIL APPLICATIONS:
